CalARVC Member Benefit Programs

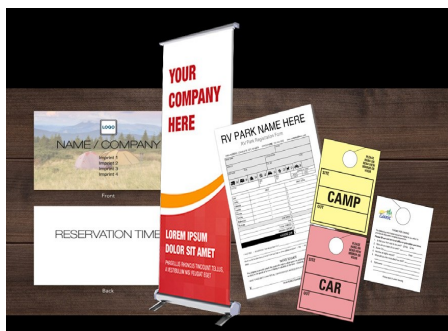
